The Georgia Marble Festival Committee reserves the right to change/edit these Rules & Regulations at any time. Vendors who have submitted applications will be notified of any Rules & Regulation changes after the time of submission. Participation in previous festival does not guarantee acceptance in future festivals.

## \*\*NO SMOKING OR PETS ALLOWED ON FESTIVAL GROUNDS\*\*

There is no rain date, so come prepared rain or shine. Set-up is allowed during allotted times ONLY. Set-up times for the 40<sup>th</sup> Annual Georgia Marble Festival are:

## Break down time is 6:00 p.m. Saturday and 4:00 p.m. Sunday

Booths must be set-up and ready for business by 9:30 am on Saturday and Sunday. Booth must always be manned during festival hours both days. Vendors are responsible for setting up and taking down booth space. Vendors are responsible for cleanup of area. Booths will not be allowed to break down prior to festival closing at 6 p.m. Saturday and 4:00 p.m. Sunday. Food Booths are 15' x 15'. If you require additional space, an additional booth will need to be purchased.

A complete food menu list must be included with application. Vendors selling food items, including mixes and pre-packaged food items will be required to provide a certificate of insurance which list Georgia Marble Festival as an additional insured.

Pepsi Beverages and Jasper Coca-Cola are one of the major sponsors of the festival, therefore Food Vendors are only allowed to sell their products. Pepsi & Coca-Cola drinks must be purchased from the Pickens County Chamber of Commerce. Drinks will be available at the festival for \$12.00 per case, equaling \$.50 each. We ask that you charge our patrons \$1.00 per drink. The only exceptions to this drink policy will be those vendors offering home-made tea or lemonade, and smoothie or slushy type drinks. Ice may be purchased for \$2.00 a bag.

No promotional products or materials will be allowed to be distributed or sold. No clothing items may be sold or distributed that have advertisements for any causes, businesses, or products on them, unless sponsorship fee has been paid for and obtained. No political material or fund raising for causes will be allowed inside the Market Place area.

Music is restricted to the Headliner Stage, only exception is a vendor booth selling musical instruments.

Welcome Packet will be given at time of check-in with information on booth assignments, set up instructions, parking information and vendor badges. NO PARKING ALLOWED INSIDE THE GATES (this also includes trailers, campers, etc.).

The Marble Festival Committee holds the right to remove any vendor from the Marble Festival who does not adhere to the above rules & regulations.
